Nature of Proceedings: ORDER EXTENDING TIME TO RULE (HABEAS CORPUS)

Petition for Writ of Habeas Corpus by Petitioner Leslie Van Houten, represented by Rich Pfeiffer, Esq. Respondent, the Governor of the State of California, represented by Deputy Attorney General Jill Vander Borgh. Time to rule extended.

Petitioner is a state prisoner with a petition for writ of habeas corpus currently pending before this court. The petition was filed on January 25, 2018. The court issued an order to show cause on March 1, 2018. Respondent filed a return on May 3, 2018, and Petitioner filed a traverse on May 22, 2018. The court's ruling is currently due on June 21, 2018. (Cal. Rules of Court, rule 4.551(f).)

The court requires additional time to adjudicate the petition. The court, on its own motion, is extending time to rule on the petition by 10 days, up to and including July 1, 2018. (Cal. Rules of Court, rule 4.551(h).)

The Clerk is ordered to serve a copy of this order upon Rich Pfeiffer, Esq., as counsel for Petitioner, and upon Deputy Attorney General Jill Vander Borgh, as counsel for Respondent, the Governor of the State of California.
